EFFECTIVE JULY 1, 2008 SOUTHAMPTON TOWNSHIP - CUMBERLAND COUNTY WILL IMPLEMENT THE SOUTHAMPTON TOWNSHIP GARBAGE COLLECTION ORDINANCE, #2008-02, DATED APRIL 14, 2008. THIS ORDINANCE PROVIDES FOR INTERSTATE WASTE SERVICES TO PERFORM GARBAGE COLLECTION SERVICES FOR ALL RESIDENTIAL CUSTOMERS WITHIN SOUTHAMPTON TOWNSHIP - CUMBERLAND COUNTY. BUSINESSES WITH COMMERCIAL GARBAGE COLLECTIONS WILL NOT BE INCLUDED IN THIS PROGRAM.

QUARTERLY BILLS WILL BE ISSUED BY SOUTHAMPTON TOWNSHIP - CUMBERLAND COUNTY TO BE EFFECTIVE JULY 1, 2008. QUARTERLY BILL RATES ARE AS FOLLOWS:

FULL SERVICE (INCLUDING 95 GALLON TOTE, 2 LARGE TRASH CONTAINERS OR SIX (6) 15 GALLON BAGS) -	\$46.45
SR. CITIZEN DISCOUNT (65 YEARS OF AGE OR OLDER) FULL SERVICE (INCLUDING 95 GALLON TOTE, 2 LARGE TRASH CONTAINERS OR SIX (6) 15 GALLON BAGS) -	\$42.21
INDIVIDUAL 33 GALLON BAGS (TO BE PURCHASED FROM SOUTHAMPTON TOWNSHIP)	\$3.75
